Independent Review of the Sensory and Communication Support Service (SENCOM)

I write, on behalf of the Welsh Local Government Association (WLGA), to notify you of our decision to commission and support an independent review of the SENCOM (Sensory & Communication Support Service). The review, will be led by **Mark Geraghty**, an independent SEND Consultant with substantial experience of working in the education/ALN/SEN sectors.

SENCOM, is a joint service covering five local authorities in South East Wales; **Blaenau Gwent, Caerphilly, Newport, Monmouthshire & Torfaen.**

SENCOM has been delivering a wide range of highly, specialist services and interventions, to families and schools, during a period when the Welsh Government's aspirations to support children with Additional Learning Needs (ALN) in schools, with appropriate levels and type of support, has been a central principle of its proposed new legislation.

The WLGA, represents all 22 local authorities in Wales, and in this case is supporting the five partner authorities in this important evaluation of SENCOM's work. The review will examine how effectively SENCOM:

- meets the specialist teaching, learning and communication needs of children and young people, it helps?
- supports families and schools to meet the children and young people's respective aspirations?
- prepares young people with sensory and communication needs to become valued and valuable adults, in their local communities?

It is essential that we capture stakeholder views of how the service is operating from their perspective, and that will be done by enabling everyone to complete a questionnaire (attached) and, in most cases, have the opportunity to attend a meeting with Mark.

The views and evidence presented will be collated to inform a final report comprising independent findings and recommendations back to the partner authorities.

WLGA and partner local authority's, believe the mark of a caring society is indicated by how we treat children who are most in need of our support. Every child, whatever their background and no matter what challenges they
